DEPOSITS/PAYMENTS

1. A non-refundable \$500.00 deposit is required to hold your pick-of-puppy. Deposits must be paid by cash, Postal Money Orders (these can only be purchased at the U.S. Post Office) or PayPal. Pick-of-puppy is based on a first deposit received basis. Deposits are Non-refundable. Happy Home Kennels reserves the right to refuse or cancel the sale of the puppy at any time for any reason. In the event Happy Home Kennels cancels the sale, the buyer will be refunded all monies in full.
2. It is understood that at the time of this sale that the puppy is not guaranteed to be of Show or Breeding Quality. It is also very important to have a vet that is knowledgeable about bulldogs.
3. Final payment must be made before the puppy can leave Happy Home Kennels. If final payment is on the same day as pick up you must bring CASH. PayPal payments must be made two business days before pickup date.

All payments are to be made in Cash, Postal Money Order or PayPal. (No Exceptions)

4. All SHIPPING COSTS are the buyer's responsibility.
5. Buyer will pick up the puppy by the time it is 8 weeks old; otherwise there will be a \$25.00 per week boarding charge, plus any other expenses, unless agreed upon and notified by seller in writing. Two weeks or more with no attempt to make pick up arrangements after this time, the buyer forfeits puppy and any deposits or payments made on puppy, unless noted by seller in writing. _____ **initials**

The seller agrees to furnish the buyer with the necessary all vaccine and worming records.

The IOEBA temporary puppy registration papers will be provided to the Buyer at the time of pick up. The buyer understands that this puppy will be eligible for permanent registration with the IOEBA, and has been fully informed on how to go about the process of registration.

Said puppy has been raised in a family environment and socialized to maximize potential to the best of the breeder's ability.

THIS PUPPY IS BEING SOLD WITH:

A) **Limited Rights (No Breeding Rights)**

The Buyer must spay or neuter the puppy before it is 12 months of age. Proof of a veterinarian certificate stating that the procedure was done will need to be provided to Happy Home Kennels.

*IF buyer decides within the first year he/she wants to obtain breeding rights before any sterilization procedures take place they can do so by contacting Happy Home Kennels and buying the breeding rights for **\$300**. After we receive payment, we will send written paper work and contact registry to have the pup's papers changed.*

B) **Full Rights**

If the puppy is a female, she cannot be bred before two years of age and must ensure she is healthy and suitable to whelp a litter before each breeding. If the puppy is male, it must not be bred before one year of age.

THIS BULLDOGGE IS GUARANTEED AS FOLLOWS:

1. To be in good physical condition for the first 72 hours after the time of delivery to buyer or buyer pickup.
2. The Buyer agrees to have puppy examined by a Veterinarian within 72 hours after delivery time/ or pickup for a complete physical examination. If the Veterinarian finds the puppy to have a serious physical condition other than a bacterial infection, including but not limited to Coccidian or Giardia, which is easily treated, the seller will replace puppy with another Puppy of comparable quality when available from same OR upcoming litter after the first puppy is returned to seller. No Monies will be refunded. The seller reserves the right to a second Veterinarian opinion at the expense of the seller. If a Veterinarian does not examine the puppy within 72 hours after delivery time, all guarantees are no longer in effect. The buyer is required to supply a copy to the seller of the initial Vet Health Examination within 7 days of the visit for the guarantees to be valid.
3. Puppy will have received age -appropriate vaccines and dewormings under Happy Home Kennels' Care. **PLEASE NOTE No replacement will be given in case of PARVO.**
4. Seller assumes no liability in the event of any accident involved with your pup/dog including, but not limited to, dog bites or personal property damage. Seller suggests proper socialization and training is given to benefit the dog and the owner.

THE BUYER/OWNER AGREES:

1. The puppy cannot be given away or sold to any other individual without the consent of Happy Home Kennels. In the event that the buyer cannot keep the puppy or provide proper care, it is to be returned to Happy Home Kennels OR if buyer finds a new home for the pup the new owner **MUST** be approved by Happy Home Kennels, agree to this same purchase agreement, and provide all Contact Information to Happy Home Kennels.
2. Puppy can NOT be sold to Research Companies and/ or any type of company that does Human product Testing on Animals. Also, The buyer certifies that they are not acting as an agent for another individual in the purchase of this puppy and will not resell this dog to any type of mass – producing business or “puppy mill.”
3. Maintain up to date vaccines, wormings, heartworm preventative, etc.. (must agree to provide Happy Home Kennels with Veterinary records of such if requested by Page or Happy Home Kennels)
4. to keep the dog/pup in humane conditions providing proper food, water, and shelter (including indoor climate controlled shelter should be provided in extreme weather example: highs and lows temperatures, snow, ice, excessive heat etc)
5. Absolutely No excessive keeping of the dog/pup tied on outdoor chain or cable.
6. To send updated photos of the puppy/dog purchased a minimum of twice a year
7. to inform Happy Home Kennels of any/ all name changes on registration papers. And If the Pup is registered with another registration besides the IOEBA.

Failure to comply with contract requirements and responsibilities or in any way neglect the emotional or physical being of said puppy/dog - will result in repossession of said animal _____ initials

The Buyer and Seller agree that this is the full and complete agreement that exists between the parties for the sale of this puppy/dog. Any agreements made prior to this are considered incorporated herein and any modifications made to this agreement shall be made in writing or such shall not be effective.

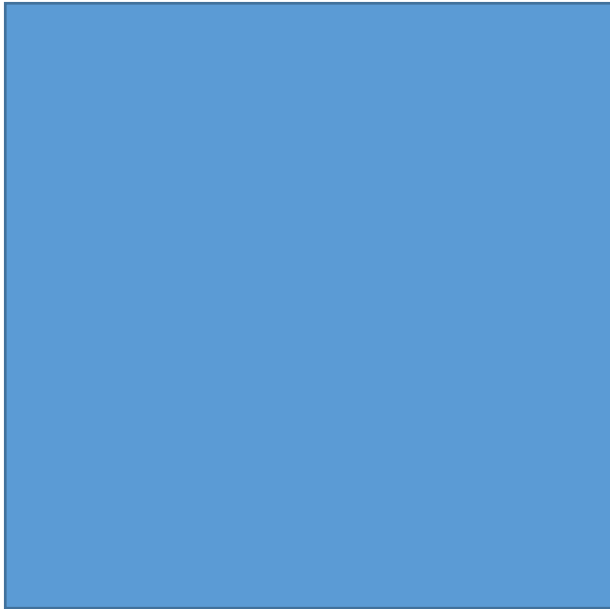
